

**TENTATIVE**  
**ORDINANCE 15/16-O-2**  
**COMBINED BUDGET AND APPROPRIATION ORDINANCE FOR**  
**THE ZION-BENTON PUBLIC LIBRARY DISTRICT FOR THE FISCAL YEAR**  
**BEGINNING JULY 1, 2015 AND ENDING JUNE 30, 2016**

BE IT ORDAINED BY THE BOARD OF LIBRARY TRUSTEES OF THE ZION-BENTON PUBLIC LIBRARY DISTRICT, ZION, LAKE COUNTY, ILLINOIS.

SECTION 1. It is found and determined by the Board of Library Trustees of the Zion-Benton Public Library District (the "District"):

- a. The tentative Budget and Appropriation Ordinance of the District for the fiscal year 2015-2016 has been made available for public inspection for at least 30 days.
- b. Pursuant to notice published at least 30 days in advance, a public hearing was held on the tentative Budget and Appropriation Ordinance.

SECTION 2. The following sums of money, or so much thereof as may be authorized by law, are deemed necessary to defray all expenses and liabilities of the ZION-BENTON PUBLIC LIBRARY DISTRICT for the fiscal year beginning July 1, 2015 and ending June 30, 2016 and are hereby budgeted and appropriated for the corporate objects and purposes specified, for the said fiscal year:






