

ORDINANCE 16/17-0-3
LEVYING TAXES FOR CORPORATE PURPOSES FOR THE CURRENT FISCAL YEAR
COMMENCING JULY 1, 2016 AND ENDING ON JUNE 30, 2017
FOR ZION-BENTON PUBLIC LIBRARY DISTRICT, LAKE COUNTY, ILLINOIS.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE ZION-BENTON PUBLIC LIBRARY DISTRICT, LAKE COUNTY, ILLINOIS THAT:

SECTION 1: A tax for the following sums of money, or as much thereof as may be authorized by law, to defray all expenses and liabilities of the ZION-BENTON PUBLIC LIBRARY DISTRICT be and the same are hereby levied, for the purpose specified against all taxable properties in the ZION-BENTON PUBLIC LIBRARY DISTRICT for the fiscal year commencing on the 1st day of July, 2015 and ending on the 30th day of June, 2016, to wit:
