This Ordinance constitutes the Budget and Appropriation Ordinance for the Zion-Benton Public Library District, Lake County, Illinois, for the fiscal year beginning July 1, 2025 and ending June 30, 2026.

SECTION 2. As part of the annual budget, it is stated:

- a. The cash on hand at the beginning of the fiscal year is \$5,329,632 (from EOY)
- b. The estimated cash expected to be received during the fiscal year from all sources is \$3,560,834.
- c. The estimated expenditures for the fiscal year are \$5,423,200.
- d. The estimated cash expected to be on hand at the end of the fiscal year is \$3,467,266 (EOY)
- e. The estimated amount of real estate taxes to be received during the fiscal year is \$2,834,073.
- f. The estimated amount of income to be received from sources other than library real estate taxes during the fiscal year is \$626,761

SECTION 3. Funds in the total amount of \$7,160,000 (SEVEN MILLION ONE HUNDRED SIXTY THOUSAND dollars) or so much thereof as may be authorized by law, be and the same are hereby appropriated as specified.

SECTION 4. All unexpended balances of proceeds received annually from public library taxes not in excess of statutory limits may be transferred to and accumulated in a Special Reserve Fund.

SECTION 5. This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
